CHALLENGE

Limited systems, visibility, and increasing demand

Nottingham University Hospitals (NUH) faced significant challenges managing Subject Access Requests (SARs) and Freedom of Information (FOI) requests. Processes were manual and inconsistent, ranging from paper forms and emails to spreadsheets, making it difficult to track progress, meet deadlines, and maintain audit readiness.

"With the volume of requests increasing, our manual process just couldn't keep up," said Marc Wilson, Head of Information Security & Data Protection. "It was clear we needed to standardize, centralize, and digitize."

The lack of visibility across teams often led to delays, confusion, and operational inefficiencies, highlighting the urgent need for a more streamlined and transparent approach.

SOLUTION

CoreStream GRC as a central hub for data protection

To meet their growing compliance and operational needs, NUH partnered with **CoreStream GRC** to implement a tailored solution for managing SARs and FOI requests. Working closely with their account manager, the team designed a system that reflected the Trust's specific workflows and priorities.

The impact was immediate and measurable. Manual processes were replaced with simple, automated tasks, reducing steps from minutes to seconds. "We went from 5-10 minutes for one task to just 5 clicks," said Andrew Tait, Data Protection & Security Support Specialist.

Staff reported saving 3-5 hours per week, while full audit trails brought greater accountability and visibility. "It's clear who's responsible for what and where each request is in the process," Andrew added.

The system also enabled long-term planning: "We can now spot trends and align resources to meet demand. It gives us real insight," said Marc Wilson, Head of Information Security and Data Protection. Training new users became effortless thanks to short, custom videos and an intuitive design, with onboarding taking under 15 minutes.

Routine tasks, like chasing FOI leads, were also automated, freeing up valuable time across the team.
