CHALLENGE

Fragmented systems and manual processes caused confusion, inefficiency, and poor transparency

UNT Health faced a fragmented compliance landscape. Initially, processes were manual with spreadsheets. Later, a legacy tool was introduced to consolidate conflict of interest disclosures. But it created confusion.

The stakes were high. Open Payments demand transparency, and UNT Health needed a solution that could support compliance.

This wasn't just a compliance team problem. Faculty, researchers, and administrators, many of whom don't live in the world of policy and regulation, were required to engage with the system. Clunky, hard to use UX/UI systems were adding to the burden.

CoreStream GRC delivered a flexible, integrated Conflict of Interest Management solution tailored to UNT Health's unique needs. The platform enabled staff to disclose potential conflicts openly, recuse from decision-making when necessary, and implement clear ethical guidelines, all while maintaining independent oversight and conducting regular reviews.

Now, with CoreStream GRC in place, the team can independently access disclosures, monitor completion status, and trigger next **steps** with HR and supervisors, all within a centralized system.

The solution was designed to be intuitive for both administrators and non-compliance staff, with customizable workflows, question sets, and automated reminders to ensure full participation and data integrity.

A key requirement was the Open Payments integration, which gave UNT Health a proactive edge in meeting regulatory transparency requirements. The side-by-side view helped users understand what data existed about them and encouraged honest disclosures.

CoreStream GRC's platform didn't just digitize a process, it transformed it. By making conflict of interest management seamless and compliant, UNT Health gained confidence that risks were being identified and addressed proactively.



- **Efficiency gains:** Time saved through automation, streamlined workflows, and intuitive design.
